

HOW YOUR DONATION HELPS FAIRFIELD COUNTY

Meet Mya - Project WISE



Mya had a problem as she entered 7th grade, school was much harder than it had been in middle school and she was quickly losing track of assignments, forgetting to do homework, and doing poorly on tests. Everything moves much faster at the junior high level and students are expected to be more independent and keep track of their own materials. As a gifted basketball player, Mya was in real danger of losing her eligibility if she didn't raise her failing grades.

Mya's teachers referred her to the WISE (Winning Interventions for Student Excellence), a class at Ridgeview STEM Junior High designed to help students transition successfully into junior high and give them the skills they would need to succeed in high school. Working closely with the WISE coach, she received the materials and support she desperately needed to stay organized, had time every day to study and work on homework, and learned how to confidently approach her teachers for help. Mya thrived and quickly began to excel in her classes, with her grades going up more than almost any other student her year. She began to help her fellow students study and encourage them to improve in the way that she did.

By the end of the year, Mya was on the honor roll, had become "Student of the Month" for her effort in WISE, continued to excel in basketball, joined a student leadership team, and became a member of student council. Mya is going to take her confidence, good work habits, and strong study skills with her as she moves to high school and college. There is no doubt that she will use her new work ethic to help her overcome any obstacle that comes her way.

Meet Clyde - Salvation Army Samaritan Center

His wife can continue working because of the care of the Samaritan Center and the use of United Way funding. The client has dementia. He attends the Samaritan Center five days a week. He was an attorney in Columbus. He made several poor financial decisions that impacted his family before they realized that he had dementia. About the time his wife realized the depth of the confusion, they had a house fire. They lost almost everything. Because of his confusion, he had let the house insurance lapse. His family tried to care for him and at one time he lived with their daughter so that his wife could work many hours to help clean up the financial mess. Currently, Alzheimer's respite dollars are used a couple days a week, but United Way dollars help make the five days of care possible allowing his wife to continue working.



Meet Bill & Jayce - Big Brothers Big Sisters



Big Brother Bill and Little Brother Jayce were matched in 2018 and became quick friends. Jayce is 9 years old. He has a history of being bullied at school because he likes different things than most kids his age. He had low self-esteem. His mother had goals for Jayce. She wanted him to learn social skills, dealing with the bullying and someone to help encourage his education. Once the bullying started at school, he no longer enjoyed attending and his grades fell

Bill is 76 years old. He has always been involved in the community and public service projects but this was a new adventure for him. He spoke to other bigs, gathered information and took the leap. He is thrilled to be a Big Brother and loves to share his story.

"I wish there were more Bill's in the world to help all the kids like Jayce," said Jayce's mom. "Jayce is finally able to be himself with Bill. His self-esteem and self-confidence has already improved."

addition to all the paperwork to be managed, Jake was determined to fundraise the \$3,500 needed for the project, which he did. He then had to lead the project of actually installing the monument. He estimates that there were more than 250 person-hours involved. This shows an example of one young man demonstrating his leadership abilities, but it also got not only his troop but members of the community at large involved in honoring those first responders and giving of their time for the betterment of the community.

A client entered the shelter with 3-month-old twin girls. This young mother came into the shelter beaten down, unsure what to do or where to even begin. She got settled into the shelter



and began working with the staff as well as outside agencies to work on independence, staying sober, taking care of her young children and herself and had hopes of getting her other daughter back from her sister. Despite the odds, this client worked hard with counselors and case managers, saved money to secure a place to live and built self-esteem. She found housing and was able to move her family into their own apartment. They left the shelter and continue to do well.

For 22 years, volunteers from schools and offices all over Fairfield County give the gift of time and participate in Community Care Day. Community Care Day is an all-day event where volunteers help support local non-profits by completing projects that might not get done because non-profits usually do not have the time or the resources. VITA

The VOLUNTEER INCOME TAX ASSISTANCE (VITA) program provides free tax preparation to any individual or family earning less than \$54,000. Since 2007, UWFC has served over 9,000 tax clients helping clients claim over \$15 million in refunds.

TCE

The TAX COUNSELING FOR THE ELDERY (TCE) program provides free tax preparation to any individual over age 60. Beginning in 2012, UWFC serves over 600 elderly clients each year.

United Way Offers Free Tax Preparation

In Fairfield County, hardworking individuals and families are finding it difficult to keep up financially. The cost of living continues to rise while wages seem to be faltering. If individuals and families are to realize long-term financial stability and independence, they must have access to tools and resources to maximize their income and help them begin to build assets for themselves and the next generation.

The Earned Income Tax Credit (EITC) helps bridge the gap between what people earn and what is needed to survive. Claimed on a person's tax return, it is designed to supplement wages and reward work. Depending on income level, marital status and the number of dependent children, taxpayers earning less than \$54,000 can claim the EITC and receive a refund of up to \$6,269. The IRS estimates that approximately 20% of eligible workers do not claim the EITC. Recognizing the EITC's potential benefit to individuals, families and communities, The United Way of Fairfield County completed its 12th year as a Volunteer Income Tax Assistance Site (VITA) and its 9th year as a Tax Counseling for the Elderly (TCE) site for the 2018 tax season. Through these programs, United Way offers free tax preparation for low- to moderate-income individuals and families in Fairfield County as well as any person over the age of 60.

United Way's VITA site utilizes IRS Certified Volunteers to prepare and file tax returns. The goal is to continue to increase the number of claims of the Earned Income Tax Credit (EITC) in our county. During the 2018 filing season, the United Way of Fairfield County was able to provide free tax preparation to 1,816 tax clients, an increase of 3% over 2017 (1,763 returns filed). The site also provided Earned Income Tax Claims totaling over \$794,000. In total, the VITA site provided \$2.38 million in federal refunds and over \$200,000 in state refunds.

The United Way strives to increase tax assistance efforts and community awareness of the EITC and asks that you be a part of these efforts in whatever capacity possible. Consider becoming a volunteer tax counselor, make a donation, or refer eligible family, friends and neighbors to our free tax assistance program. Our goal is to help individuals and families in the community receive the tax credits they are entitled to, avoid costly fees, and receive the money they deserve!
